CARDEROCK SAVES THE BAY! Carderock's Skipjack Trip out on the Bay Save the Date: Saturday, May 14

Join your neighbors for a half-day adventure on the Stanley Norman single-masted sail boat where we'll learn about oysters, the life of a Chesapeake Bay Waterman and Bay-related issues of the past, present and future.

The Chesapeake Bay Foundation shares their philosophy with us: "To care for the environment, you must love it. To love it, you must know it. To know it, you must experience it".

As you have read in previous newsletters, Carderock is saving the Bay by having neighbors work together to install rainscapes and conservation plantings. House by house, residents are planting to reduce storm water runoff and pollutants before they go into our storm drains and into the Chesapeake Bay.

The boat leaves at 9 a.m. from the Annapolis City Dock, for which we have directions. The Carderock Citizens Association has subsidized the cost of our tickets. Habitat for Humanity Restore:

As I have mentioned before, if you are in search of any household or construction products, this is a good place to start. If you have any home project or renovation extras left over and still in usable condition, consider donating them. Proceeds go to the Habitat construction projects for low-income citizens. There are often sales, and you can find used and new items from house décor, to hardware, tools, tiles, cabinets, fixtures and more., all donated by individuals, as well as contractors and construction companies. The shop in Gaithersburg (formerly off of Shady Grove Road) has a new location at

1029 East Gude Drive, and is open from 9-6 Monday-Saturday, and 10-4 Sundays.

Farther afield is Community Forklift, a huge warehouse of mostly used and vintage items, plus displays by several antique and vintage decor dealers.

Montgomery County Solid Waste:

Reminder for our community, and especially for those who have recently moved here from other counties, states or countries, our local waste department has a website montgomerycountymd.gov/sws/ that you can access in order to request a bulk or scrap metal pick-up, to order a new recycling bin or to request a pick-up of an unusable bin.

In addition, under "trash and recycling", you can access information on "how to dispose of..." for almost any item imaginable. If a particular item is not in the listing, you can even submit your request and you will get a personal response. In addition, instead of relying on my CS-chat messages re. changes in collection, you can get personally notified of any changes if you register with them.

Food Packaging:

Reminder that as of January 1, 2016, using foam food packaging and packing peanuts are prohibited in Montgomery County.

Toxins:

In the last edition of this newsletter, I reported on where the research stands on the use of triclosan and triclocarbon and the FDA's activities to review the safety and effectiveness of those particular products where these chemicals are used. In a recent Wall Street Journal report on Health Care (Feb. 16, 2016) several others were mentioned, including isopropyl alcohol (especially for those in health-care professions), benzalkonium chloride (for carcinogenicity and potential hormonal effects), benzethonium chloride (for fertility and body weight at birth, and subsequent development), iodine (especially frequent topical use by certain health-care personnel), and chloroxylenol (exposure following repeated use).

Where are these found? The list is quite long, but hand-sanitizers, wound-cleaning, cosmetics, soaps, body washes, cosmetics, toothpaste, kitchenware, health-care antiseptics, creams, ointments, and more may contain one or more of these chemicals.

Even though an individual may use these products for a few seconds and then wash them down the drain, their negative effect on the environment may last for decades. In addition, although they may play an important role in health-care settings, their everyday use and effect in households, in our food and in our bodies is up for scrutiny.

Both sides of the debate have submitted evidence supporting their stance, to confuse the matter. The research includes all antiseptic products used in our battle against germs, at home and even in hospitals to fight the rise in virulent bacteria.

The biggest concern is antibiotic resistance, and that by over-using antibacterials to prevent spread of disease to people who are not infected (as opposed to antibiotic drugs prescribed to cure disease), we are contributing to this problem. These antibacterials can linger in the environment and can be absorbed in the body, and thus may affect the creation of superbugs that are resistant to the antibiotics used to fight them.

Next September , the FDA will announce a decision regarding whether these chemicals are safe and more effective than plain soap and water.

If you are a consumer of items at "Dollar Stores' or other mass merchandisers, be aware that although lead and cadmium, two potent neurotoxins that have been regulated by consumer protection, there are others that are not so scrutinized. Before you purchase any of these or any such products, for more information you can access:

<u>Gardening for Food</u>: There was recently a bit of discussion on the CS-chat regarding growing vegetables from seeds indoors vs. outdoors vs. purchasing seedlings. The Washington Post published a comprehensive chart on Thursday, Feb. 11 that you can access to find out specifics for our area. Another method comes from the area of Phenology, or the study of cyclical and seasonal natural phenomena, especially in relation to climate and plant and animal life. Here are some suggestions for our area:

Plant chard, beets and onions when the daffodils bloom

Plant peas when the maple trees flower

Plant beans and cucumbers when the apple trees drop their petals

Transplant tomatoes into the garden when the peonies flower

Although our food gardens need protections from our local foragers, in the form of fencing or netting, there might be a bit of space here and here in your ornamental garden for some lettuces or small food-producing plants. They can be decorative as well.
