## **County Plan for Fenway Road Trial Islands**

The Montgomery County Department of Transportation has provided the following information to the CSCA community on the two <u>trial</u> traffic islands that are to be placed on Fenway Road north of Still Spring Court:



"Our Division of Traffic Engineering and Operations (DTEO) will move forward with installation of two trial islands. Here is what you can expect:

- 1. Two trial islands will be placed on either side of the Fenway Road cul-de-sac near 8305 and 8308 Fenway Road.
- 2. One trial island will be located on the west side of Fenway Road approximately 45 feet south of the cul-de sac, The second island will be placed on the east side of Fenway Road approximately 40 feet north of the cul-de-sac.

- 3. Temporary pavement marking tape will be installed to delineate the trial island width (one and half feet) and length (40 feet), about three to three-and- a-half feet of space will be provided behind each island.
- 4. Within the delineated trial island, five flex posts will be installed, these flex posts will be white with retroreflective tape and about three feet tall.
- 5. The County will install "quick curb" along the area of the flex posts which replicates the dimensions of the permanent concrete islands.
- 6. In addition, white and yellow temporary pavement marking tape will be installed to delineate the edge lines and a double yellow centerline providing 10 to 10.5-foot travel lanes. The double yellow centerline and white edge lines will begin at Still Spring Court and extend approximately 10 feet beyond the driveway for 8305 Fenway Road.

The trial period will be extended to run for four months instead of three months. The four-month trial period will run from late October 2017 through late February 2018. During this trial period, DTEO will conduct a one-week speed and traffic volume study. The data will be collected at three different locations in advance, within and after the area marked with trial islands. All data and analysis collected will be provided to the Carderock Springs HOA [CSCA] to assist the community in making a determination on whether to proceed with installation of permanent physical islands. "

At the September Board meeting there was support to extend the trial island period from the originally planned three month period to four months to better assure that the impacts of winter weather could be accurately determined. The Board had also requested that the Department of Transportation conduct additional speed studies, either prior to the installation of the islands in late October or following their removal in late February. The County, however, did not agree to this request and indicated that the prior speed studies conducted in April and October 2016 would be sufficient to measure any differential in speed.

The Board intends to appoint a committee to assist in evaluating the trial islands and ultimately conducting a survey of the community on the perceived efficacy of installing permanent islands as a means of traffic calming. We are looking for individuals with experience in conducting surveys and/or familiar with statistical analysis, and preferably individuals who are not predisposed to a given result, in order to help inform this decision. Any interested persons should contact myself, or any other member of the CSCA Board, as soon as possible.

- Basic rights of citizens to peaceful use and enjoyment of their homes has been removed without prior notice or discussion
- Purposely did not move to be near an airport...10 miles away one should not expect such constant disruption
- Decision was made without input from our state, county or community to assess environmental impact
- Life style costs of technology / transportation should be shared equitably by residents in all three adjoining jurisdictions
- If you have elementary school aged kids, specifically, planes are routed over the school
  during the day and at recess time. Jet engines emit particulates that are physically and
  chemically toxic to health, specifically to the lungs. It has been shown that particulate
  emissions are highest in landings and takeoffs, which is what we have been experiencing
  with these low-flying jets.

## **Architectural Review Committee Meetings**

## 1<sup>st</sup> Wednesday of the month, 7:30 pm

The Citizens' Association has an Architectural Review Committee (ARC) meeting on the 1<sup>st</sup> Wednesday of each month at the Clubhouse. If you are considering an addition or exterior modification of your home, submit your plans for review by the 20<sup>th</sup> of the month. Design and review procedures plus other documents are available at CarderockCitizens.org. The ARC was created by the covenants which govern your property in Carderock. ARC meetings are open for any and every community member to attend, whether you are renovating or not.



## **Recent Exterior Modifications Considered by ARC**

As required by the covenants recorded against each lot for a Bennett home in Carderock Springs, any outside modification or additions to the structures on a lot must be reviewed and approved in advance by the Architectural Review Committee (ARC). This may include, but is not limited to the following: fencing, sheds, exterior color schemes, and live, sound hardwood tree removal. The ARC is an appointed committee comprised of residents who are trained as architects/designers. The ARC meets on a monthly basis, generally the first Wednesday of each month, starting at 7:30 pm at the Club, to review applications and plans for exterior modifications to Carderock homes. Meetings are open to all residents.

If you are considering an addition or exterior modification of your home, please submit an application and your plans for review to the ARC beforehand. Initially these can be early conceptual plans and then later on they can be construction drawings with specific elevations. The ARC can often assist homeowners with suggestions on design issues that have arisen with other homes in the past and possible workarounds.
