This referendum is expected to be conducted online (with paper copies available upon request) in late February or early March. This year, we plan to organize a talent show and a wine and cheese tasting party, in addition to other social events. The CSCA also appoints the Architectural Review Committee that approves exterior modifications to homes, sheds and fences and enforces the community covenants if issues arise. Finally, but certainly not least of all, the CSCA is the voice of the community in addressing external County and other local issues. The voluntary dues that are paid to the CSCA allow us to continue to serve the neighborhood.

The Carder-Eco Column News from the Environmental Committee

<u>Carderock Tree Walk</u>: Two years later, we are again planning the very informative and successful local tree walk with Conservation Montgomery. Representatives come to our neighborhood with us to demonstrate and teach us how to care for our own trees. Preregistration will be required. Details as soon as date is confirmed for late April or early May.

<u>Community–wide Yard Sale</u>: After lots of success with and requests for another community yard sale, we will again be planning one for the Fall.

<u>C&O Canal work</u>: Major improvements to the canal between 2018-19 are now set to preserve the park's historic structures, allow them to withstand flooding, and keeping the parks and tow path well-maintained. There will be temporary detours during this process and we will keep you informed to help ensure that the empty canal in our area gets refilled when improvements have been completed.

<u>The Great Backyard Bird Count</u>: Feb. 16-18, register beforehand at http://gbbc.birdcount.org/ if you are interested in participating. Includes a minimum of 15 minutes of counting birds you see at any location.

Montgomery County Solid Waste: It is often difficult, especially for newcomers, to ascertain whether various trash items are approved for disposal into our co-mingled blue bins or whether they belong in the trash. To simplify, you can place all numbered items # 1-7 into the bin except #6. This includes clean containers from bakery products, clamshells, plastic cups, deli trays and containers, fruit and vegetable containers and baskets, tubs and domes, individual plastic plant pots, non-hazardous aerosol cans, bimetals (steel/tin) and aluminum cans, and buckets from cleaning supplies or cat litter.

Clean paper products can go into the paper bins, including magazines, junk mail, newspapers, envelopes (even those with clear openings), paper with staples, books, phone books, any papers from packaging materials, as well as wax coated food containers such as those for milk. Please clean these before disposing in the paper bin.

<u>County Solid Waste website</u>: Need a new blue bin? How to trash or otherwise dispose of some specific items? How to arrange for a free bulk pick-up or a metal pick-up? Access the county site at https://www.montgomerycountymd.gov/sws/ to help you with any of these. Within the site, there are links to requesting bins, links to the specific items you are concerned about, and scheduling a pick-up. The county phone number is 311 and you can access many departments using that. In addition, you can contact dianekarlik@verizon.net for any question or try the cschat as many often do.

Montgomery County Quiet Skies Coalition (MCQSC)



MCQSC leaders Anne Hollander and Janelle Wright engaged in a lively discussion with Carderock residents at the semi-annual CSCA Community meeting on November 5, 2017. Many members of the Carderock community are deeply concerned about increasing airplane noise and pollution and expressed their support to MCQSC's effort. To summarize the MCQSC presentation:

For 70+ years DCA arrivals & departures followed routes along the Virginia side of the Potomac River. In recent years, FAA made two changes that dramatically shifted air traffic over DC and Maryland:

- 1. Moved flight paths (ARRIVALS) from the Virginia side of the Potomac River to the Maryland side.
- 2. Implemented <u>NextGen</u> Performance Based Navigation (greater precision allows more flights into busy airspace, airplanes fly closer, in narrow flight corridors). In our area, this meant re-routing DEPARTURES into more narrow corridors.

(Quiet Skies Coalition, cont.)

Flights occur every 1-3 minutes, from 5:30 am to past midnight, 7 days a week, creating a constant noise over our community. Low altitude arrivals create unbearable noise, which disturbs sleep, concentration, and general wellbeing of affected residents. The louder and longer the exposure, the greater the risk of cardiac effects, anxiety, cognitive impairment. The situation is complicated by the fact that DCA area involves 3 different jurisdictions. Complaints from Montgomery County residents expected to increase over 500 times since 2015. FAA study by Booz-Allen & Hamilton Inc. shows a 19% drop in value for moderately priced homes under flight paths. MSQSC was created by 19 communities, including Carderock, to collaborate with citizens, governments, and the DCA Noise Working group aiming:

- 1. to return to pre-NextGen paths (disperse the impacts)
- 2. equitably allocate the air traffic so that all local jurisdictions are equally burdened by the noise and pollution
- 3. move flight paths away from residential communities as much as possible
- 4. impose meaningful noise level restrictions
- 5. establish meaningful nighttime and early morning limits
- 6. move more air traffic to underutilized Dulles

MCQSC informs and involves the following State and County elected officials in finding solutions: Governor Hogan, MoCo Executive Leggett, County Council President Berliner, State Delegate Korman.

Congressional Strategy includes work with Representative Raskin, Senators Van Hollen and Cardin, National Quiet Skies Caucus (about 40 members in the US House of Representatives) on amendments to FAA Reauthorization and Infrastructure/Transportation Funding. Furthermore, collaboration with other jurisdictions around the country is in place as NextGen is a national problem.

Legal Strategy Group is exploring if FAA failed to comply with the National Environmental Policy Act (NEPA) when flight paths changed (City of Phoenix just won a lawsuit against FAA with similar facts). County/State may file – case is under investigation.
