We are a community recognized by the **National Register of Historic Places** as a prime example of Situated Modernism, where houses complement and blend in with the natural landscape.

Proposed Beltway Expansion Will Directly Impact Carderock Springs and South Carderock

The recently released information from the State Highway Administration (SHA) of the seven remaining alternatives being considered for the expansion of the I-495 Beltway and I-270 indicate that our community will be directly impacted, with some homeowners on Hamilton Spring Rd, Stone Trail Rd, Tomlinson Ave., Osage Ln. and Thornley Rd possibly losing parts of their yards and a larger portion of the community being exposed to higher noise and potential air pollution emissions.

Adding these lanes results in an expanded right of way (orange line) and limit of disturbance (narrow pink line) with several homes on Hamilton Spring Rd, Stone Trail Rd, Thornley Ct, Tomlison Ave, Osage Ln and Cypress Grove Ln losing parts of their yards.
- 2. Adding elevated ramps (thick pink) over the Beltway linking Managed Lanes and River Road on each side of the highway expanded the area affected by noise and air pollution.
- 3. Red dotted line shows areas 66 dB contour going through Carderock Springs Elementary school, its field and first row of houses next to Beltway on each side.
- 4. Stormwater ponds (in blue) are planned for the area between Tomlison Ave and Beltway and behind Seven Locks Rd.

Beltway Tree Planting Update

Based on our community request in the meeting with the SHA on February 10th, SHA has initiated a project to **install fast growing evergreen** tree plantings to supplement existing vegetation within SHA ROW (Right-of-Way) along I-495 Inner & Outer Loop from Seven Locks Rd to Persimmon Tree Road. The expected Planting **Completion Date is June 30, 2019.** If there is an impact due to the Beltway widening, SHA will evaluate tree relocation options.

Sara Love Speaks at CSCA Annual Meeting

Sara Love, newly elected Maryland District 16 Delegate, was the speaker at the CSCA Annual Meeting on April 28, 2019. Love provided an overview of her work in this Spring's legislative session and answered community members' many questions.

Love began by alerting the audience to several items of legislation that successfully passed the General Assembly in its recently-completed 2019 session:

- Maryland voted to ban polystyrene (i.e. Styrofoam) food containers
- The Maryland minimum wage will increase to \$11 in July 2019, then by an additional dollar each July until the rate reaches \$15 in 2023
- The Clean Energy Jobs Act passed and will increase the state's renewable electricity standard to 50% of the total grid by 2030 and requires the state to examine pathways for achieving 100% clean power by 2040. It encourages offshore wind power development and small- and large-scale solar energy production.

Love was also happy to share that the legislature overrode Governor Hogan's rules about determining school calendars at the state level and put this decision-making back in the hands of local government.



Most of the conversation during the Question and Answer session concerned Beltway Expansion. Love, who serves on the Environment and Transportation Committee, sponsored and co-sponsored legislation regarding Beltway Expansion (HB 663, HB 102) that unfortunately did not pass during the session.

She noted that, unfortunately, the Maryland legislature's ability to impact state highway development is limited. Governor Hogan has single-mindedly pursued adding two lanes in both directions on I-270 and I-495 and has not been receptive to considering alternative plans, many of which have been proposed. Love encouraged us as a community to "continue to push on this" by writing letters to our legislators and other public officials.

Other topics covered included continued development in downtown Bethesda, solar energy panels in Maryland's agricultural preserves and whether Maryland might pass a law requiring major candidates to release their taxes to the public in order to appear on the ballot. Love encouraged constituents to communicate with her and her office frequently. She can be reached at

<u>Updated Info to File Aircraft</u> <u>Noise Complaints</u>

Please continue to file aircraft noise complaints and encourage your neighbors to do so as well!! It is important to submit your online complaints properly.

Unfortunately, we have confirmed that a significant number of noise complaints submitted through the third party vendor, Airnoise, are not actually being received and counted by MWAA's complaint system. MWAA does receive many complaints through Airnoise, but a significant subset are not going through. This seems to occur when the link between the Airnoise registration and the MWAA registration is not working properly -- which can be hard to determine.

Therefore, for most users we are recommending that you STOP using Airnoise and send complaints only by using the MWAA website or app. Needless to say, it's important that if you are taking the time to file a complaint, it needs to be counted!

Planning a renovation?

ARC Approval and Architectural Salvage

If you're planning a renovation to your Carderock Springs home, there are two important things to know before you begin work: Architectural Review Commmittee (ARC) approval for exterior modifications and architectural salvage for interior renovations.

EXTERIOR: MODIFICATIONS CONSIDERED BY ARC



As required by the covenants recorded against each lot in Carderock Springs, any outside modification or additions to the structures on a lot must be reviewed and approved in advance by the Architectural Review Committee. This may include, but is not limited to the following: fencing, sheds, exterior color schemes, and live, sound hardwood tree removal. The ARC is an appointed committee comprised of residents who are trained as architects/designers. The ARC meets on a monthly basis, generally the **first Wednesday of**

<u>each month</u>, starting at 7:30 pm at the <u>Club</u>, to review applications and plans for exterior modifications to Carderock homes. Meetings are open to all residents, whether you are renovating, planning to renovate or interested in listening.

Please submit an application and your plans for review to the ARC beforehand. Initially these can be early conceptual plans and then later on they can be construction drawings with specific elevations. The ARC can often assist homeowners with suggestions on design issues that have arisen with other homes in the past and possible workarounds. As the project becomes more defined, homeowners should return for another meeting to review construction drawings with specific elevations. Additionally the ARC may make recommendations and want to see amended drawings and details.

Specifics on the ARC submission process and the application form are on the CSCA website which also has a 20 page document of architectural guidelines that reflect the architectural standards the ARC looks for in exterior modifications, outdoor landscaping features and sheds. Lawn Pesticides

Lawn companies and some homeowners filed a suit against the county ... and lost!
Still not a reality totally, but is a step in the direction of safety to families, growing kids, pets, certain animal species, water safety and other aspects of the environment.

Pesticides cannot be used on lawns for "cosmetic purposes" but can still be used in garden areas, golf courses and farmland. These chemicals can still be sold in Montgomery County.

What exactly does this all mean for us? You can still purchase and apply it yourself in your gardens but not on your lawn? That is what it seems to say. However, there are alternatives so please go to a local business that sells garden materials and find out what else you could use.



Maryland Court of Special Appeals upholds Montgomery County's law banning pesticides on lawns

Court reverses Circuit Court's 2017 ruling that struck down measure

ROCKVILLE, Md., May 3, 2019— The Maryland Court of Special Appeals on [May 2] sided with Montgomery County, reversing the Circuit Court's ruling that invalidated the County's 2015 law banning the application of certain dangerous pesticides to lawns for cosmetic purposes.

The court sent the case back to the lower court and directed it to enter a judgment in the County's favor.

"This is a big win for our environment and the public health," said Councilmember Tom Hucker, chairman of the Council's Transportation and Environment Committee and one of the bill's lead sponsors, along with then-Councilmembers George Leventhal and Marc Elrich. "It also affirms our County's authority to protect our residents, especially our kids, from the harmful threats that pesticides and other environmental toxins can pose."

"This court decision is a great victory for our County's public

health and environment," said County Council President Nancy Navarro. "We must not relent in exercising our right to enact sensible legislation that protects our residents from harm. As president of the County Council, I will continue to work with my colleagues to make our County a healthy place for all our residents to live, work and play."

"The Supreme Court held in 1991 that the principal federal law governing pesticides permits such local legislation," the court wrote. "We conclude that the ordinance does not run afoul of State law."

In its decision, the Court of Special Appeals cited the late Rachel Carson of Silver Spring and her groundbreaking book "Silent Spring," published in 1962, which led to a ban of the toxic pesticide DDT.

"Carson's examination of the health impacts of DDT and other pesticides galvanized the public, and the next decade saw Congress enact a broad range of statutes that are foundational to modern environmental law," the court wrote. "Montgomery County claims, in essence, that it is following in these footsteps, but we must determine whether it has done so consistently with State law."

After the County Council passed the law in 2015, it was sued by a group of homeowners and landscaping companies, which claimed that the County law should be struck down because it banned pesticides that had been approved by the federal government.

In August 2017, the Montgomery County Circuit Court ruled in favor of the plaintiffs, calling the law an example of overreach by the County.

The County appealed the lower court ruling to the Court of Special Appeals.

The law acknowledges that while certain pesticides can be useful in agriculture and when protecting (C

some natural resources, they also contain dangerous toxins and should not be applied for solely cosmetic purposes, such as on lawns. The law does allow pesticides to be applied to farmland, golf courses and gardens, and does not prohibit their sale in the County.

The Court of Special Appeals found that "state law does not expressly pre-empt local government regulation of pesticides."

It also rejected the lower court's finding that allowing individual jurisdictions to establish their own pesticide regulations could cause "chaos and confusion in the marketplace":

"For decades, Maryland's
Chesapeake and Atlantic Coastal
Bays Critical Area Protection
Program has authorized certain
counties to regulate pesticides
within the Critical Area without any
record of chaos and confusion for
multi-tiered regulation," the court
wrote.

It also said that while the state's pesticide statutes reference conformance with federal legislation, this is "best regarded as an aspirational goal, rather than an obstacle to local legislation."


