We are a community recognized by the National Register of Historic Places as a prime example of Situated Modernism, where houses complement and blend in with the natural landscape.

# **Beltway**

The State Highway Administration (SHA) contractor has begun installing the plant material along the I-495 inner and outer loop and should be completed by 6/21/19. This replanting was requested by many residents and the Carderock Springs Citizens' Association (CSCA) in the community meeting with SHE on February 10. The project includes about 130, 5 ft high Leyland Cypress (68 on the Outer Loop and 62 on the Inner Loop), and 100, 5 ft hgt. Green Giant Arborvitae (77 on the Outer Loop, and 23 on the Inner Loop). These trees will be interspersed among the existing vegetation. SHA will evaluate relocation options of new trees as during its I-495 widening plans.

On June 5, 2019 the Maryland Board of Public Works moved the I-270 widening project to be before the I-495 widening project. I-495 widening plans have been delayed by two years which will allow more time to better involve affected communities and counties (thanks so much to all Carderock neighbors who submitted their comments and signed the petition!).

On June 12, 2019 CSCA submitted a letter with Comments about alternatives retained for detailed study & concerns about planned Beltway expansion to Governor Hogan, Administrator Slater and SHA representatives responsible for this project. The Walt Whitman High School PTSA Cluster issued a statement in support of Beltway Noise and Air Pollution Mitigation to Governor Hogan, Administrator Slater and SHA representatives. Many thanks to Karen Roman for coordinating with all three schools' PTSA's in order to submit this timely request to protect our community, including school-aged children from air and noise pollution caused by the I-495 beltway.

# **Montgomery County Quiet Skies Coalition**

Jamie Raskin joined 28 other Members of Congress in requesting that the U.S. Government Accountability Office (GAO) investigate "how the Federal Aviation Administration (FAA) has considered community noise impacts while implementing the Next Generation Air Transportation System (NextGen) in major metropolitan areas," including the Washington, D.C. metropolitan area.

The Secret Service asked FAA that all planes use GPS computer-controlled approaches/departures because of incursions into restricted airspace in DC. This will include general aviation aircraft as well as the current flights, resulting in a narrower band of flights (more density) and more planes in that band. While the problem with incursions was due to problems on departures, arrivals are also being included in the new procedure. This new procedure is planned to be implemented in mid-August.

# News from the Environmental Committee

#### Tree and shrub care

It is important to remove climbing ivy and other vines from the trunks of trees. Many trees in CS yards are covered, and thus would encourage insect infestations as well as its extra weight and tendency to accumulate water weight during rainy spells, all of which can cause tree damage or falling trees. In addition, standing water can also encourage mosquito breeding.

If you are going to prune azaleas or other Spring flowering shrubs, this should be done right away and before the buds are set for next year's bloom.

#### Mulch

When using mulch, it is healthier for the tree if the mulch is not piled around the base of the trunk where it meets the ground. All you need to do is to pull the mulch away from that area so air can penetrate the base.

There have recently been reportings of pet dogs being poisoned by ingesting cocoa mulch, a type of gardening mulch readily available that attracts those pets who like to eat almost anything. If you use it, you need to monitor your dog. In addition, check the bags for "pet approved" varieties, and be sure there is no or little caffeine or the compound theobromine. Should you use this type of mulch in a garden along the road, please leave a little sign for those residents who walk their dogs past your home.

#### **Plastics**

A recent book by Michael Webber, entitled *Power Trip: The Story of Energy*, states that "Bottled water is at least 1,000 times as energy-intensive as water from the tap, and offers few if any benefits". That should encourage us to use our own refillable bottles.

A New report finds plastic production and use could have the equivalent impact of nearly 300 new coal power plants on Earth's climate over the next decade.

Plastic is polluting oceans, freshwater lakes and rivers, food and us but is also a major contributor to global climate change, warns a new report.

Scientists, policymakers and consumers are increasingly aware of the threat plastic pollution poses to oceans and water, wildlife, food and people. However, often lost in calculating plastics' environmental harm is its contributions to climate change.

# Planning a renovation? ARC Approval and Architectural Salvage

If you're planning a renovation to your Carderock Springs home, there are two important things to know before you begin work: Architectural Review Commmittee (ARC) approval for exterior modifications and architectural salvage for interior renovations.

### **EXTERIOR: MODIFICATIONS CONSIDERED BY ARC**

As required by the covenants recorded against each lot in Carderock Springs, any outside modification or additions to the structures on a lot must be reviewed and approved in advance by the Architectural Review Committee. This may include, but is not limited to the following: fencing, sheds, exterior color schemes, and live, sound hardwood tree removal. The ARC is an appointed committee comprised of residents who are trained as architects/designers. The ARC meets on a monthly basis, generally the **first Wednesday of** 

<u>each month</u>, starting at 7:30 pm at the <u>Club</u>, to review applications and plans for exterior modifications to Carderock homes. Meetings are open to all residents, whether you are renovating, planning to renovate or interested in listening.

Please submit an application and your plans for review to the ARC beforehand. Initially these can be early conceptual plans and then later on they can be construction drawings with specific elevations. The ARC can often assist homeowners with suggestions on design issues that have arisen with other homes in the past and possible workarounds. As the project becomes more defined, homeowners should return for another meeting to review construction drawings with specific elevations. Additionally the ARC may make recommendations and want to see amended drawings and details.

Specifics on the ARC submission process and the application form are on the CSCA website which also has a 20 page document of architectural guidelines that reflect the architectural standards the ARC looks for in exterior modifications, outdoor landscaping features and sheds.
