# **Community Meetings on Beltway Expansion**

The Carderock Springs Citizens Association (CSCA) is planning two community meetings to help the neighborhood respond to the planned widening of the Washington Beltway which runs adjacent to Carderock Springs and Carderock Springs South. The planned construction includes two additional lanes running in each direction, as well as the addition of elevated access lanes at the River Road intersection with the Beltway. On Sunday, March 29 at 7:00 pm, the CSCA is holding a neighborhood meeting at the Carderock Springs Swim and Tennis Club for residents to discuss the issues that affect the neighborhood resulting from this project. These issues include the potential taking of private property from homeowners living adjacent to the Beltway, the construction of barriers in the right-of-way to mitigate the noise and environmental impacts of the widened Beltway, and developing strategies on how the community can respond to the P3 program, including commenting and reviewing the Environmental Impact Statement when issued, commenting on the final P3 agreement and discussion on what specific action items we want our State and County legislators to undertake on our behalf with respect to this project.

To this end, a Beltway Noise Working Group has already been formed comprised of interested community residents that has begun to look into these issues. In March they will be providing comments to the draft SHA Cultural Resources Technical Report issued in December. Carderock Springs Citizens Association is listed as a Consulting Party to this report due to the historic status of Carderock Springs. We welcome the participation of other community members as well to assist this group.

We rely on the \$50 per house annual dues to fund activities that directly benefit the community, including providing this





### River Road Entrance Light Replacement



CSCA has completed a project to replace the two halogen entrance light fixtures on Carderock Springs Drive near River Road with a single energy-efficient LED flood light. The new lighting fixture will result in a power usage drop from 500W to less than 50W. We anticipate a significant corresponding decrease in our PEPCO electric bill, which will likely cover the entire cost of the project in 3 months.

After trialing a couple of options over the past week, the CSCA Board settled on the fixture currently in place. Special thanks to one of our CSCA Board Members, Ashish Goel, for undertaking this *electrifying* effort. # Golf Course Re-grading at Congressional Country Club

Those massive mounds of bare dirt may be next to our neighborhood for a while longer because earth-moving on the golf course is scheduled to occur for another two years. To re-grade their golf course, Congressional had received approval from Maryland National Park and Planning Commission (MNCPPC) to remove over 17 acres of their Forest Conservation Easement, which had been protected for its capacity to absorb and filter storm water. Yet the approvals granted that 10.14 acres of unprotected tree critical root zone could be excluded from the required reforestation.

Representatives of the Carderock Springs Citizens Association met with the project engineers and staff at MNCPPC in November. We expressed our concerns at that meeting to the project engineers and County representatives about how the removal of the trees and vegetation bordering our neighborhood will increase the volume of storm water flowing from Congressional's property into our neighborhood. The MNCPPC report stated that 3,467 inches of DBH (diameter at breast height) of trees will be removed and 867 inches in DBH will be planted (plus 228 caliper in transplants). This is roughly one-third of the mass for storm water retention. New planting on the golf course has not been scheduled until fall 2020. It has been described as grassy meadows with some 3" caliper trees, although we haven't seen a plan yet. Some sodding may occur this spring.

Unfortunately, the sediment control fencing that was installed to filter runoff during construction hasn't been working. Following winter storms, the creek which runs from Congressional's

property has run brown with sediment and we have observed brown runoff flowing through the surrounding woods into the creek.



The MoCo Department of Permitting Service (DPS) has met with the contractor, delivered citations and even for a short period stopped work. The CSCA has been communicating with DPS and MNCPPC and we hope that better measures will be installed.

The creek which flows down from the golf course through a culvert beneath Fenway Road into Cabin John Creek collects and conveys a huge volume of runoff. Last summer this culvert collapsed during a major storm closing Fenway Road for over four months. As a condition to receiving the approval for the regrading, Congressional was required to contribute over \$800,000 to the MNCPPC Parks Dept. for stream restoration. The understanding was that these funds would go for the creek's restoration. Prior to construction, the stream banks of the creek were already severely eroded from excessive runoff. The slopes surrounding the new culvert are collapsing and need to be stabilized.

The CSCA is working to ensure that it happens. We have sent letters and are trying to get some answers from County officials.

I have recently been reading various articles by Leyla Acaroglu (
leylaacaroglu.com),
a well-regarded sustainability
provocateur, a sociologist, designer and expert in environmental change. This particular quote caught my eye.

"The undeniable issue is that we have created a disposable culture, and no amount of recycling will fix it." – Leyla Acaroglu

It is difficult but not impossible to change the way we live. "Single-use throwaway stuff permeates our day-to-day lives; it's hard to avoid a coffee cup here, a plastic bag there, some wooden chopsticks at lunch, or that boxed take-out Thai food for dinner. While it's most prevalent in the food industry — bottles, cups, lids, straws, grocery bags, produce bags, cutlery, produce wrap, and even those single-serve little sauce sachets — recently, design for disposability has moved into the medical, transport, and government sectors just as much. Over the last 60 years since the invention of cheap plastics,

and even more so in the last 15 years, since the rise in the cult of busy, we have literally designed ourselves into a disposable society." "As awareness about environmental issues associated with waste has risen, so too has the quick fix of "make it recyclable" as a solution to disposability. This has validated the production of single-use product streams. It has given way to the myth of 'good' (paper) and 'bad' (plastic) materials, which is so problematic as all materials have impacts, but it also has distracted us from the real issue all whilst more and more products and services have shifted to disposable from reusable."

How can we begin to deal with this? A more local food system, whether it be our local Co-op or seasonal produce markets or bulk food providers, could result in less packaging since items such as clamshell containers protect for time and distance ...that is not necessary if local and/or purchased at such stores.

When you take out food, such as a sandwich, ask for minimal packaging. Instead of accepting a box or larger than necessary container, ask for it to be wrapped in waxed or food grade wrapping paper. You could also bring your own reusable container. If you consider it a must to continually hydrate yourself by carrying single use bottles of water, consider a refillable and reusable one instead. Do the same with your coffee.

Whereas most of us reuse our shopping bags each time, and wash them often, I know that we have been less strict in using the plastic produce bags. One can purchase lightweight reusable and washable produce bags instead, and take them along with your reusable larger shopping totes to corral your selections of produce and have those weighed.



# IS CSA (Community Supported Agriculture) FOR YOU?

CSAs are basically farms that are supported by community members in a variety of ways (work, fees) in exchange for fresh and local produce. Each one is different, some deliver, some require you to visit the farm, some have recently tried to individualize a family's portion.

Check **mocoalliance.org** and search for information on CSA's. Here's a start:

http://www.mocoalliance.org/comm unity-supported-agriculture.html Now is the time to do this, as many fill up quickly and early. You will see descriptions specific to each farm.

If you have found a CSA you like, please post the name on CS-chat@groups.io . It would then be reasonable and possible for neighbors to coordinate and/or "carpool" to pick up weekly produce, saving time, fuel and energy.

# Planning a renovation? ARC Approval and Architectural Salvage

If you're planning a renovation to your Carderock Springs home, there are two important things to know before you begin work: Architectural Review Commmittee (ARC) approval for exterior modifications and architectural salvage for interior renovations.

#### **EXTERIOR: MODIFICATIONS CONSIDERED BY ARC**



As required by the covenants recorded against each lot in Carderock Springs, any outside modification or additions to the structures on a lot must be reviewed and approved in advance by the Architectural Review Committee. This may include, but is not limited to the following: fencing, sheds, exterior color schemes, and live, sound hardwood tree removal. The ARC is an appointed committee comprised of residents who are trained as architects/designers. The ARC meets on a monthly basis, generally the **first Wednesday of** 

<u>each month</u>, starting at 7:30 pm at the <u>Club</u>, to review applications and plans for exterior modifications to Carderock homes. Meetings are open to all residents, whether you are renovating, planning to renovate or interested in listening.

Please submit an application and your plans for review to the ARC beforehand. Initially these can be early conceptual plans and then later on they can be construction drawings with specific elevations. The ARC can often assist homeowners with suggestions on design issues that have arisen with other homes in the past and possible workarounds. As the project becomes more defined, homeowners should return for another meeting to review construction drawings with specific elevations. Additionally the ARC may make recommendations and want to see amended drawings and details.

Specifics on the ARC submission process and the application form are on the CSCA website which also has a 20 page document of architectural guidelines that reflect the architectural standards the ARC looks for in exterior modifications, outdoor landscaping features and sheds.
