We are a community recognized by the **National Register of Historic Places** as a prime example of Situated Modernism, where houses complement and blend in with the natural landscape.

MONTGOMERY COUNTY QUIET SKIES COALITION UPDATE:

Some Relief Is Already In The Air!

Good news! Although airplane activity out of Reagan National Airport (DCA) is down approximately 70% from pre-COVID levels, starting January 1st Carderock residents may have noticed a *further* decrease in airplane noise due to a shift of the North Flow Westerly <u>DCA</u> <u>Departures</u> from the Carderock Springs residential area further south to non-residential areas adjacent to the Potomac River. This is thanks to the work of the Montgomery County Quiet Skies Coalition that collaborated with Montgomery County and Arlington County to hire an aviation consultant to advise the FAA on noise reduction alternatives.

Also, this aviation consultant developed a proposal to manage <u>arrivals</u> to <u>DCA</u> from the north by better dispersing aircraft over Montgomery and Fairfax Counties and the Potomac River instead of having 100% of these flights channeled over residential areas of Montgomery County. If after 180 days of testing this new approach is successful, the incoming flight tracks would no longer be concentrated over the western section of Carderock Springs as arriving aircrafts would be more spread out. In that case, we could expect considerable moise relief from airplanes in the latter half of 2021 or early 2022.

<u>KUDOS</u> to the Coalition's first big successful outcome and to the tireless work with Montgomery and Arlington Counties, their aviation consultant and the important progress in negotiations with the Federal Aviation Administration.

Congressional Country Club Forest Conservation Plan Amendment Approved

Several Carderock residents testified and/or submitted written testimony to the Montgomery County Planning Board for its public hearing on January 28, 2021 regarding an amendment to the Forest Conservation Plan for Congressional Country Club (CCC). The amendment was requested in order to allow CCC to clear more trees and forest conservation areas on site to allow it to build a performance golf practice center near the intersection of Bradley Boulevard and River Road.

The thrust of our testimonies was that under the existing Forest Conservation Plan as amended in summer 2019 which allowed for the removal of hundreds of trees and acres of forest conservation areas on the CCC property to allow for the mass grading of its golf course, the stream running under Fenway Road which flows into Cabin John Creek has become full of sediment following major rain



storms. Further, the velocity and intensity of the water flow in the stream has increased thereby contributing to the erosion of the stream bank. Despite our holding several meetings with staff of MNCPPC and DPS to alert them to these conditions, which resulted in notices of violation to CCC, these conditions have persisted over the past eighteen months.

The staff of the MNCPPC acknowledged during the hearing that only about 25% of the on-site plantings that are required by the Forest Conservation Plan had actually been planted on the CCC property. More plantings will be installed in spring/summer of 2021. The engineer for CCC also stated that CCC was going to be performing additional stream stabilization work in the streambed on its property. We are trying to learn more about exactly what that entails as he was not specific during the hearing.

The outcome of the Planning Board hearing was an approval of the requested amendment for CCC to allow it to cut further trees albeit most of these are located near the site of the performance golf center. The chair of the Planning Board did, however, acknowledge that the original plan had not worked as well as it should have, and that staff would be conducting regular inspections to insure that the continuing sediment run-off was stopped.

Everyone is encouraged to monitor the stream conditions, and to report any noticeable run-off to the Forest Conservation Plan inspector, Steven Peck, at stephen.peck@montgomeryplanning.org.

Governor Hogan Is Accelerating His Beltway Expansion Effort

On January 27, the Maryland Department of Transportation (MDOT) formally recommended going forward with Alternative 9 for the Beltway expansion. Carderock Springs' part of the Beltway will be in the first phase of the expansion, which will widen I-495 by adding two new toll lanes in each direction between the American Legion Bridge and the I-270 spur. This plan would also create four toll lanes on I-270 by adding to each side one new lane for tolls and turning an existing HOV Lane into a second toll lane.

Although the FEIS (Final Environmental Impact Statement) isn't due until Fall 2021, the developer should be announced in early February. A programmatic agreement is planned to go to the Board of Public Works in Spring 2021. According to MDOT, this agreement should "advance the preliminary design to further avoid and minimize impact to environmental resources, communities, properties, utilities, and other features by working with the counties, municipalities, state and federal agencies, property owners and citizens". However, since selecting Alternative 9, MDOT demonstrated that communities' concerns haven't been heard and there is a concern that this trend will continue.

Carderock Springs had previously expressed its concern to MDOT about Alternative 9 because it would significantly shorten the distance between the Beltway and school/residences and increase harmful noise/air pollution. Carderock Springs in its many letters to MDOT and County representatives opposed any Alternatives (including Alternative 9) that wouldn't limit the road expansion to the current Right of Way (ROW).

In a public meeting on January 7, Maryland state legislators expressed significant concerns with MDOT's rush to advance the procurement process before comments to the Draft Environmental Impact Statement are addressed in the FEIS and the record of decision for the FEIS is made. Delegate Korman and Delegate Solomon are currently introducing bills to assure transparency, accountability and promises that the State made regarding the Beltway expansion. Council President Hucker will be scheduling a February meeting with Comptroller Franchot about the I-270/I-495 project. 

Montgomery County requires all dogs outside an owner's premises be leashed with exceptions for service dogs, designated dog exercise areas or other approved activities. Planning a renovation? ARC Approval and Architectural Salvage

If you're planning a renovation to your Carderock Springs home, there are two important things to know before you begin work: Architectural Review Committee (ARC) approval for exterior modifications and architectural salvage for interior renovations.

EXTERIOR: MODIFICATIONS CONSIDERED BY ARC



As required by the covenants recorded against each lot in Carderock Springs, any outside modification or additions to the structures on a lot must be reviewed and approved in advance by the Architectural Review Committee. This may include, but is not limited to the following: fencing, sheds, exterior color schemes, and live, sound hardwood tree removal. The ARC is an appointed committee comprised of residents who are trained as architects/designers. The ARC meets on a monthly basis, generally the **first Wednesday of**

<u>each month</u>, starting at 7:30 pm at the <u>Club</u>, to review applications and plans for exterior modifications to Carderock homes. Meetings are open to all residents, whether you are renovating, planning to renovate or interested in listening.

Due to the coronavirus, the ARC meets via Zoom. If you are PLANNING A RENOVATION, PLEASE CONTACT THE ARC by email cscaARC@gmail.com for the zoom link and further instructions regarding your plans for review and approval. Applications can also be dropped off at 8009 Hamilton Spring Rd.

Please submit an application and your plans for review to the ARC beforehand. Initially these can be early conceptual plans and then later on they can be construction drawings with specific elevations. The ARC can often assist homeowners with suggestions on design issues that have arisen with other homes in the past and possible workarounds. As the project becomes more defined, homeowners should return for another meeting to review construction drawings with specific elevations. Additionally the ARC may make recommendations and want to see amended drawings and details.

Specifics on the ARC submission process and the application form are on the CSCA website which also has a 20 page document of architectural guidelines that reflect the architectural standards the ARC looks for in exterior modifications, outdoor landscaping features and sheds. Composting Food Scraps

Please be aware that the county requires a rodent proof compost bin for food waste with a tight fitting lid. The free ones supplied by the County do not. Open containers where you have placed food attract rodents to our yards and homes. The county will soon be evaluating and testing receptacles that might be distributed in the future.

County Trash & Recycling Pick Ups

President's Day week our trash pick up will be on Wednesday Feb. 17 instead of the usual Tuesday Feb 16. Trash and recycling cans should not be left out until the afternoon of the day prior to pick up.

Recycling Bins & Bulk Pick Ups

Phone 311 any time to request a replacement bin from the Solid Waste department or to request a FREE special metal or large bulk pick-up.

Clothing Donations

It is preferable to donate to organizations which you have investigated via https://www.charitynavigator.org/ or or https://www.charitywatch.org/ or to local organizations and charities such as The National Center for Children and Families on nearby Greentree Road, Salvation Army, Goodwill, or other charities that hand over the needed clothing to those underserved who actually receive it directly and immediately.

While other charities say that donations "support" those in need, some, like Planet Aid or Pick Up, for example, ship clothing to developing countries which can undermine the

developing fiber and clothing industries that these poorer countries are trying to encourage.

Recycling Plastics

There has been a spike in contamination of recyclables by COVID-related waste, and the effect of contaminated recycling is that it ends up being incinerated or in a landfill. Single use disposables such as masks and gloves should be put in the trash only.

In addition, since the price of oil is so low, it is currently cheaper for manufacturers to use virgin plastic instead of recycled material. The gap between the two has seen a significant increase throughout the pandemic because for companies it does not make financial sense to pay more for recycled material. However, there is an associated and additional environmental cost that will have to be "paid" at some point in the future. Refining the raw materials and the eventual cost of pollution and increased waste may very well increase environmental and health damage.



"Only 9% of all plastic ever produced has been recycled. About 12% has been incinerated. The other 79% has accumulated in

landfill, dumps and the natural environment, where it often ends up washing into rivers via wastewater, rain and floods. Much of it eventually ends up in the ocean," according to The Guardian.

On January 1, 2021, an important new law tackling plastic pollution came into effect. It was an amendment to the Basel Convention, which controls the movement of hazardous waste between countries, and thanks to pressure from Norway, was expanded to include plastic. Nearly every country in the world (186 nations) signed

on to the amendment, but unfortunately, the United States was not one of them.

The amendment states that countries receiving shipments of plastic waste for recycling must be informed of its contents and give permission for those shipments to arrive. If permission is not granted, the shipment remains in its country of origin. It is a response to the flood of contaminated, mixed, and difficult-to-recycle plastics that has been dumped on many developing countries, including Vietnam and Malaysia, among others.

The logic behind the amendment is that countries that outsourced recycling in the past will now be forced to deal with their own waste. Although comprehensive recycling infrastructure is lacking in most countries and recycling rates are abysmally low - which is why they exported in the first place – the hope is that this amendment will force them to come up with better systems and solutions for dealing with waste. At the very least, developed countries will no longer be able to turn a blind eye to the sheer quantity of plastic waste they generate, nor how poorly designed for recycling much of it is. Results of the above will not be in evidence very soon...it may easily take more than 5 years to see fewer plastics polluting the planet. In the meantime and along with this new regulation, there must be a far greater emphasis on reusable, refillable, and returnable packaging, as well as materials that are truly biodegradable and homecompostable.

One solution is to minimize the use of plastics. Drinks in cans are preferable because that metal can be recycled and re-used more easily and results in less errant litter floating around in the environment and the seas.

Montgomery County Climate Action News

Montgomery County has launched a virtual information room to facilitate public review of the Draft Climate Action Plan. The County's strategic plan focuses on cutting greenhouse gas (GHG) emissions by 80 percent by 2027 and by 100 percent by 2035. The 87 climate actions outlined in the plan lay the path to achieving the County's ambitious climate goals while building a healthy, equitable and resilient community.



Residents can visually engage with the Draft Climate Action Plan using a computer or mobile device. Go to


