Updates on Beltway Widening

On June 16, the National Capital Regional Transportation Board (TRB) voted to remove the construction of the Phase One I-495/I-270 Managed Lane Project, including the American Legion Bridge, from its list of approved projects, effectively removing the project from eligibility for NEPA environmental approval needed to proceed. However, since this vote several members of the TRB have expressed their lack of understanding of the impacts of the vote and members who voted in opposition have been replaced or new members appointed to vacant seats on the TRP by individuals who are on record as supporting the Project.

On July 7, the Deputy Secretary of the Maryland Department of Transportation sent a letter to the TRB expressing his understanding that this vote would jeopardize funding for other priority transportation projects in Montgomery, Prince George's, and Frederick Counties and urged that the TRP reconsider this vote at its upcoming July 21 meeting.

On June 29, I testified on behalf of the Carderock Springs Citizens' Association at a hearing held by the joint Maryland House of Delegates Transportation and Environment Subcommittee, chaired by Delegate Marc Korman, and the Senate Public Safety, Transportation and Environment Subcommittee on our concerns about the project, particularly the proposed flyover ramps that would connect the managed lanes to the River Road exit and the Clara Barton Parkway.

following:

- Additions
- Fencing
- Sheds
- Exterior color schemes

The ARC meets monthly on the first Wednesday of each month at 7:30 pm. Meetings are open to all residents, whether you are renovating, planning to renovate or interested in listening.



When your building project is approved by the ARC, then you will receive an approval sign to post in your yard.

For summer 2021, the ARC may meet at the Club or may meet via ZOOM so if you are planning a renovation, please contact the ARC by email cscaARC@gmail.com for further instructions regarding your plans for review and approval and to get the zoom link. Applications can also be dropped off at 8009 Hamilton Spring Road.
